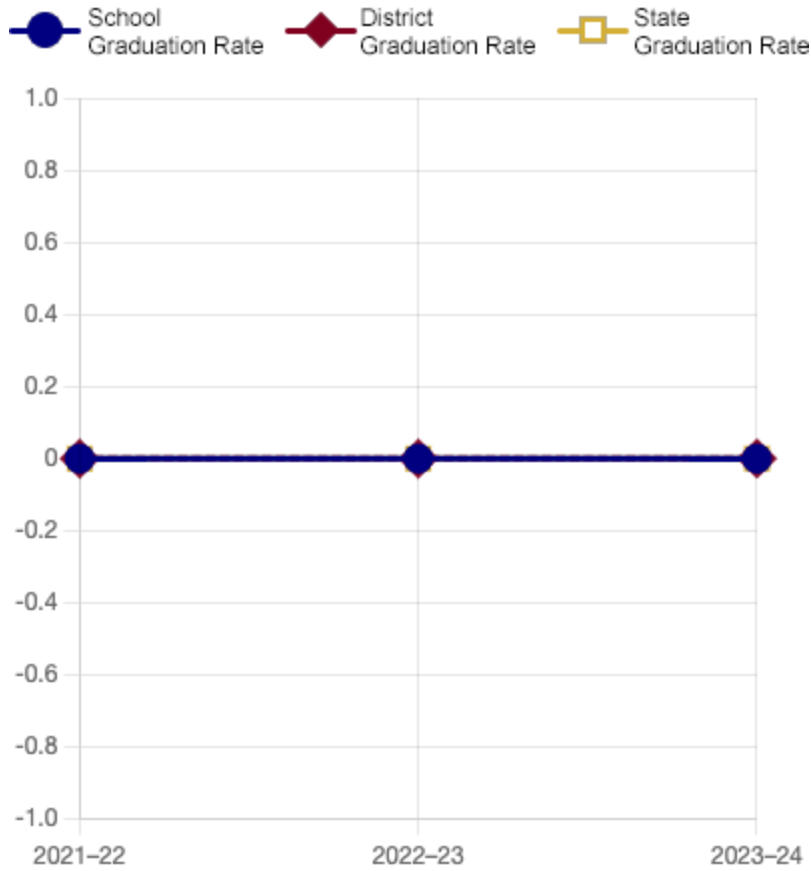

Graduation Rate and Dropout Rate (Four-Year Cohort Rate)

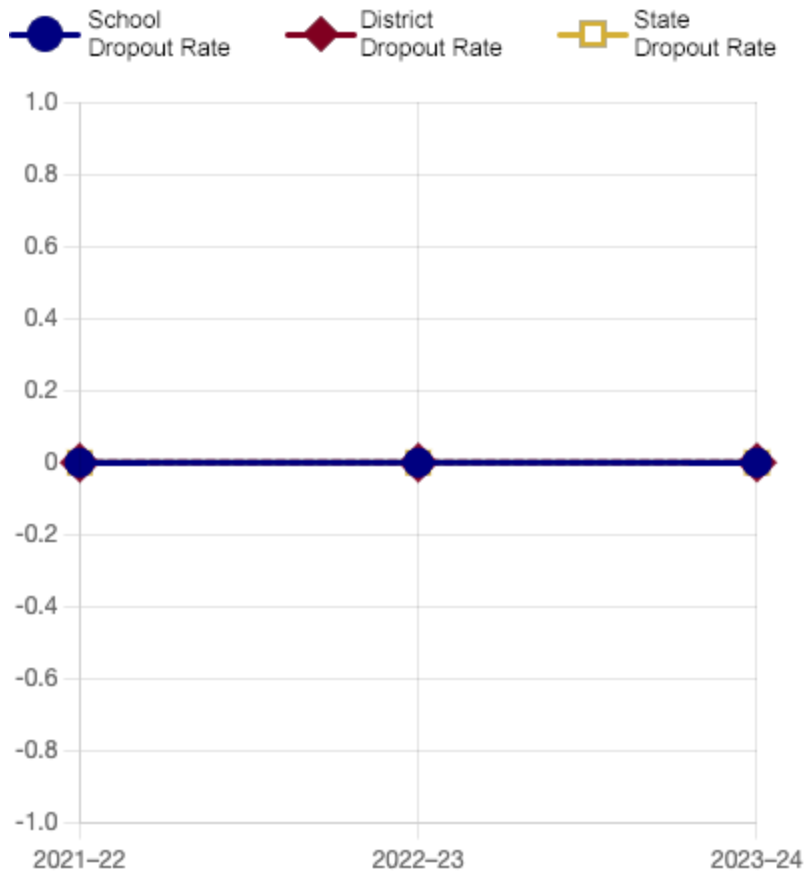

Mayacamas Countywide Middle School has a comprehensive Safety Plan that is reviewed yearly by the board and the staff. 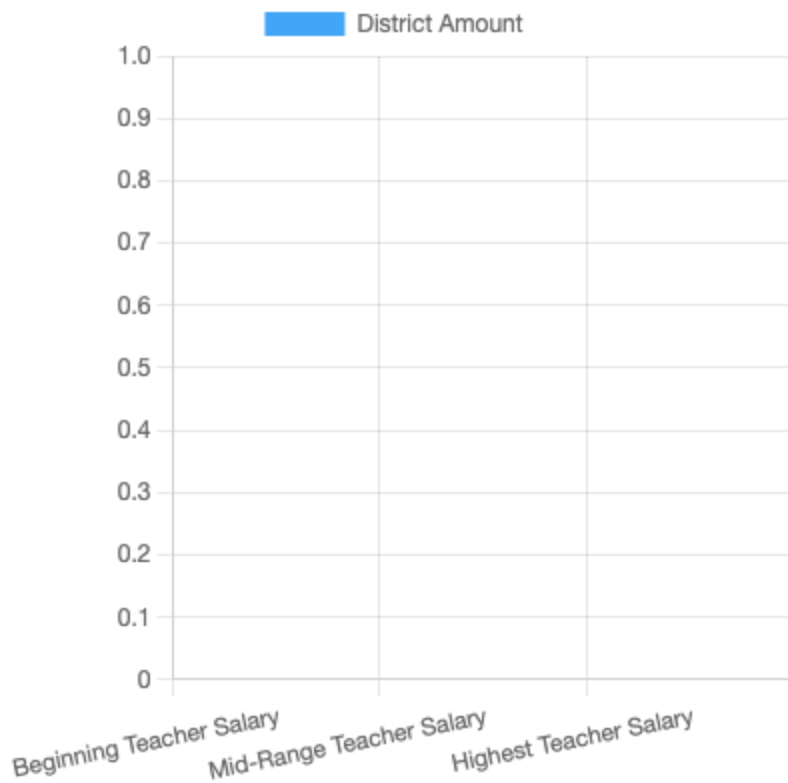
